Pursuant to § 607.1006 of The 2017 Florida Statutes, the undersigned person, desiring to amend the Articles of Incorporation of Music of Your Life, Inc., a Florida corporation, does hereby sign, verify, and deliver to the Office of the Secretary of State of Florida, this Amendment to the Articles of Incorporation for the above-named company (hereinafter referred to as the "Company"):

The amendment contained herein was approved by a majority vote of shareholders of the Company on May 18, 2018.

FIRST: The Articles of Incorporation of the Company were first filed and approved by the Office of the Secretary of State of Florida on May 18, 2018. This Amendment to the Articles will become effective upon the filing of the Articles of Amendment with the Florida Secretary of State.

SECOND: That ARTICLE II shall be amended by adding at the end thereof the following: "Effective at the close of business on May 18, 2018 (the "Record Date"), for every four thousand (4,000) issued and outstanding shares of Common Stock of the Company, each shareholder shall receive one (1) share of the Company's Common Stock ("Reverse Split"), provided however, that fractional shares shall not be issued and will be rounded up to the nearest whole share."

All other aspects of Article II shall remain unchanged.
