## ARTICLES OF INCORPORATION SECRETARY OF STATE

#### <u>ARTICLE I - NAME</u>

The name of the corporation is Berkshire Loss Consultants, Inc., at 2681 Bradfordt Drive, West Melbourne, FL 32904 (Principal Office of Registered Agent).

#### ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
