The undersigned does for the purpose of forming a corporation under the laws of the State of Florida under the corporate name R. C. SMALLBACK CONSULTING, INC., hereby sets forth and declares:

<u>C H A R T E R</u>

Article I

The name of the corporation shall be R. C. SMALLBACK CONSULTING, INC., located at City of Cape Coral, County of Lee, State of Florida.

Article II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

Article III

The authorized capital stock which the corporation may issue shall be 7500 shares of \$1.00 par value common stock, which shall be nonassessable and held, sold, and paid for at such time and in such manner as the Board of Directors may from time to time determine.

Article IV

The corporation shall commence business on filing with the Secretary of State.

Article V

The corporation shall have perpetual existence, except that the same may be dissolved, as provided by law.

Article VI

The principal place for the transaction of its business shall be 1428 S.W. 52^{nd} Terrace, the City of Cape Coral, County of Lee, in the State of Florida. That said corporation shall have the right and authority to do business at such other place or places within or without the State of Florida as the corporation may, by resolution, designate.

Nothing herein contained shall create liability in the events above described or prevent the authorized approval of such contracts in any other manner permitted by law.


