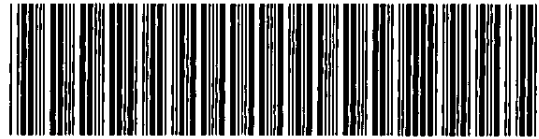


ARTICLES OF INCORPORATION  
OF

THE UNDERSIGNED, acting as Incorporator of the JULIO CONTRERAS, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following ARTICLES OF INCORPORATION for such Corporation:

ARTICLE I

NAME
