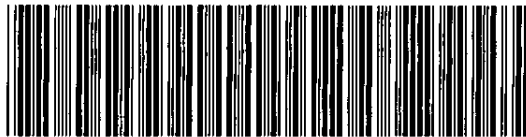

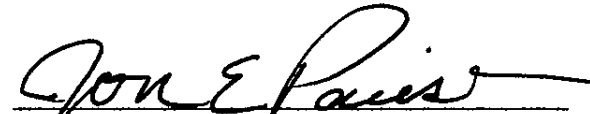
ARTICLE VI - INCORPORATOR
