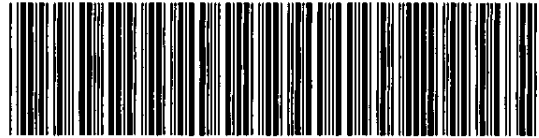

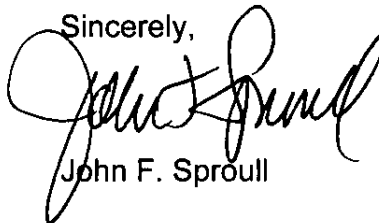

ARTICLE I - NAME

The name of the Corporation shall be HYPOCKET, INC.

ARTICLE II - EXISTENCE

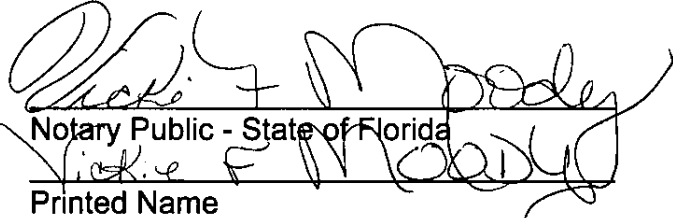
