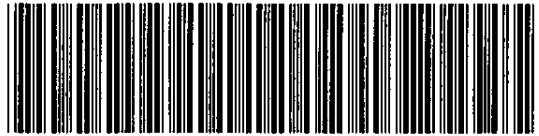

Records and Documents


