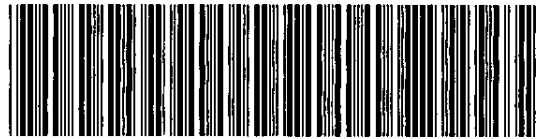

## ARTICLES OF INCORPORATION OF L C SMEBY CONSULTING, INC.

The undersigned hereby adopts the following Articles of incorporation for the purpose of forming a corporation under the laws of the State of Florida.

### ARTICLE I – NAME

The name of the corporation shall be L C SMEBY CONSULTING, Inc.

### ARTICLE II- Principal place of business and mailing address of the corporation.
