

The name of this corporation is DRO OF LAKE LAND, INC."

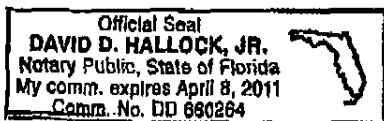
2. The foregoing amendment was adopted by the written consent of the sole Shareholder and the sole Director on December 13, 2010.
