THE UNDERSIGNED, being competent to contract, do subscribe to these Articles of Incorporation and act as Incorporators for the purpose of forming a corporation for profit under the laws of the State of Florida, and do hereby adopt the following Articles of Incorporation:

ARTICLES I - NAME

The name of the Corporation shall be RIOLEO SERVICES, INC

ARTICLES II- NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is:

- A. To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with, goods wares, merchandise, real and personal property, and services of every class, kind and description; except that it is not to conduct a banking, safety deposit, trust, surety, express, railroad, canal, telegraph, telephone or cemetery, company, a building and loan association, cooperative association, fraternal benefit society, state fair or expositions.
- B. To conduct business in, have one or more offices in, and buy, hold, mortgage, sell convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses in that State of Florida and in all other states and countries.
- C. Contract debt and borrow money, issue and sell or pledge bonds, debentures notes or other evidence of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.
 - D. To Purchase the corporate assets of any other corporation and engage in the same or other character of business.

- E. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the share of the capital stock of, or any bonds, securities, or other evidence of indebtedness created by any other corporation of the State of Florida or any other State or government, and while owner of such stock, to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
 - F. To engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE III – CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is ten thousand (10,000) shares of common stock, having a par value of \$0.01 per share.

Cumulative voting of shares is not authorized, except as provided in Shareholder Agreement to the contrary.

ARTICLE VIII – INITIAL ADDRESS OF REGISTERED OFFICE AND DESIGNATION OF REGISTERED AGENT

The street address of the initial registered office of this corporation in the State of Florida is 933 Valley View Cir. Palm Harbor, Pinellas County Florida. The Board of Directors may from time to time, without amending these Articles, move the registered office to any other address within the State of Florida.

The initial Registered Agent is designated as Jose Del Rio. The Registered agent of the corporation may be changed at any time by a vote of the Board of Directors without an amendment of these Articles.

ARTICLE IX – DIRECTORS

This Corporation shall have one (1) Director initially. The number of Directors may be increased or diminished from time to time, by a vote of the then acting Director or Directors by majority rule when approved by the Stockholders, but shall never be less than one (1).

ARTICLE X – INITIAL DIRECTORS

ARTICLE XII – INDEMNITY OF DIRECTORS AND OFFICERS

Any person made a party to any action, suit or proceeding by reason of the fact that he, or his or her personal representative, is or was a director, officer or employee of the Corporation, or any corporation in which he or she served as such at the request of the Corporation, shall be indemnified by the Corporation against the reasonable expenses, including attorney's fees, actually and necessarily incurred by him or her in

. connection with the defense of such action, suit or proceeding, or in connection with the defense of such action, suit or proceeding, or in connection with any appeal therein, except in relation to matters as to which it shall be judged in such action, suit or proceeding that such officer, director or employee is liable for negligence or misconduct in the performance of his or her duties.

The date of the corporate existence shall begin when these Articles have been filed with the Department Of State, State of Florida, according to the Statutes of the State of Florida.


