ARTICLE I - NAME

The name of this Corporation is Muscle Car Workout, Inc.

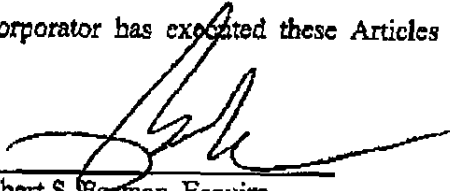
ARTICLE X - INDEMNIFICATION
