
## ARTICLE SEVEN

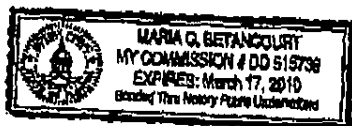
