**ARTICLES OF INCORPORATION
OF

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST. The name of the corporation (hereinafter called the "corporation") is JP Racing, Inc.
