The undersigned hereby agree to organize a corporation under the laws of the State of Florida, with the following Articles of Incorporation.

ARTICLE I
NAME

The corporate name shall be: DOORS OF MIAMI, INC.

DURATION

The corporation shall have perpetual existence.

PURPOSE



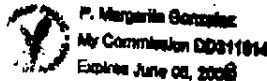
