#### ARTICLES OF INCORPORATION OF 8TH ST. WIRELESS, INC.

The undersigned does hereby subscribe to, acknowledge and files the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### **ARTICLE I - NAME**
