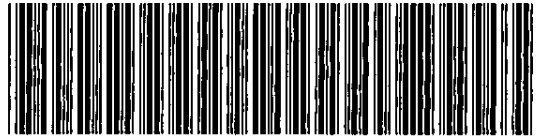



ARTICLE I. NAME

The name of this corporation is
FATHER, SON & BROTHER, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.


