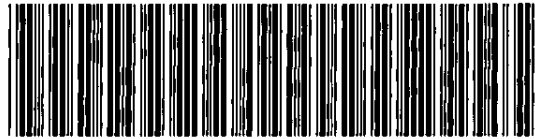

ARTICLE IV


The sole incorporator and initial director, being a majority, authorized the dissolution.
