

# ARTICLES OF INCORPORATION OF SECURE EXPORT SERVICES, INC



We, the undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the provisions of the Several Acts of Legislature of the State of Florida, do hereby subscribe to these Articles of Incorporation:

#### **ARTICLE I**

The name of the corporation is; SECURE EXPORT SERVICES, INC

#### **ARTICLE II**

The general nature of the business to be transacted by this corporation is to engage in the business of Export Services as well as other business permitted under the laws of the United States and the State of Florida.

To purchase the corporate assets of any other corporation and engage in the same or other character of business.
