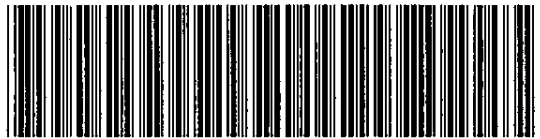



OF

"ALL AROUND HANDY MAN OF THE BAY INC."

THE UNDERSIGNED SUSCRIBER TO THESE "ARTICLES OF INCORPORATION", A NATURAL PERSON COMPETENT TO CONTRACT, HEREBY FORM A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA:

ARTICLE I.- NAME:

THE NAME OF THE CORPORATION SHALL BE :

"ALL AROUND HANDY MAN OF THE BAY INC."

ARTICLE II. NATURE OF BUSINESS:


ARTICLE X.- AMENDMENTS:



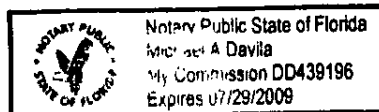
