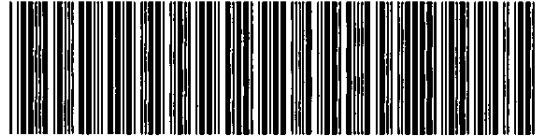

ARTICLE 1 NAME

The name of this Corporation (which is hereinafter called the "Corporation") is :
CHIMBWA SONS, INCORPORATED.

ARTICLE 11 ADDRESS

Its principal business shall be carried on at 6229 Dawson Street, Hollywood, Florida 33023, and at such other places or points in the State of Florida, and the United States and foreign countries as may from time to time be authorized by the Board of Directors.

ARTICLE 111 PURPOSE

The general nature and the objects and purpose to be transacted and carried on by this Corporation under the Statutes of the state of Florida is as follows:

SECTION 1

To engage in the purchase or acquisition of property, business rights of franchise, or for additional working capital, or for any other in or about its business affairs, without limit as to the amount, to incur debts and to raise and borrow and secure the payment of money in any lawful manner, including the issue and sale or other dispositions of bonds, warrants, debentures, obligations, negotiable and transferable instruments and evidences of indebtedness of all kinds whether secured by mortgage, pledge, deed of trust or otherwise.

SECTION 4

This Corporation shall have all the general powers together with all of the additional and specific powers granted by the laws of the State of Florida, as well as all implied powers in carrying out the foregoing powers.

ARTICLE IV NUMBER OF SHARES

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time shall be 1000 shares of \$ 1.00 per value.


