The undersigned for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE ONE  
NAME**

The name of the Corporation is TMK REALTY, INC.

**ARTICLE TWO  
ADDRESS**

CORPORATION DURATION**

The duration of the corporation is perpetual existence.

**ARTICLE FOUR  
PURPOSE OR PURPOSES**

The general purposes for which the corporation are engaged are:

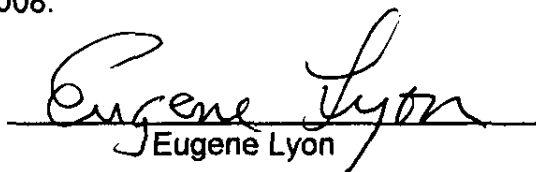

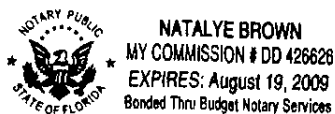

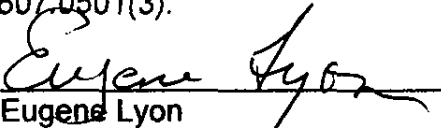
