**ARTICLES OF INCORPORATION
OF
TT OF DANIELS, INC.
(a Florida corporation)**

Pursuant to Florida Statutes Section 607.0201, the undersigned hereby submits the following Articles of Incorporation of TT OF DANIELS, INC., a corporation being organized under the laws of the State of Florida.

**ARTICLE I.
Name**

The name of the Corporation is "TT OF DANIELS, INC." (hereinafter called the "Corporation").

**ARTICLE II.
Purpose**

The Corporation is formed to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act, Chapter 607, Florida Statutes (the "FBCA"), including any amendments thereto.
