

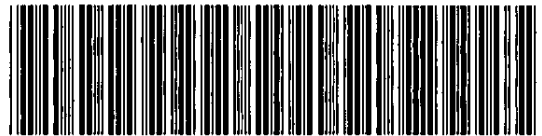

**ARTICLE I: NAME**

**ARTICLE II: NATURE OF BUSINESS**

This corporation is organized for the purpose of providing insurance sales services and transacting any or all other lawful business permitted under the laws of the Florida Real Estate Commission, the State of Florida or any other state and of the United States.
