ARTICLES OF INCORPORATION OF DOCTOR PAUL M. HELSBY, P.A.

The undersigned incorporator to this Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be DOCTOR PAUL M. HELSBY, P.A

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - INITIAL PRINCIPAL OFFICE

The initial principal office of the corporation shall be located at 1801 Kalurna Court, Orlando, Florida 32803.

ARTICLE IV - PURPOSE

This corporation is organized for the purpose of conducting a dental practice and the transaction of any and all lawful business.

ARTICLE V - CAPITAL STOCK

- A. The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock having a par value of \$1.00, which may be fractional shares.


