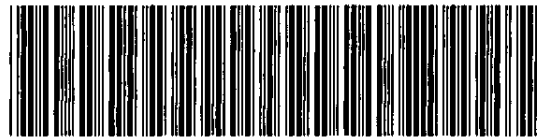

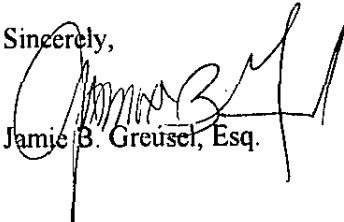

#### IX. SUBSCRIBER AND INCORPORATOR

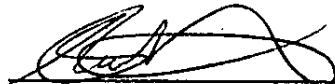
The subscriber and incorporator to these Articles of Incorporation is Santo V. Gentile.

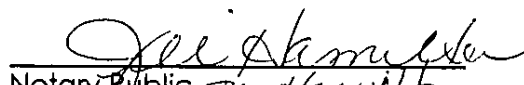

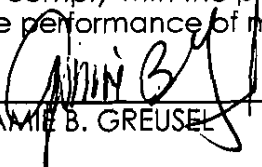
