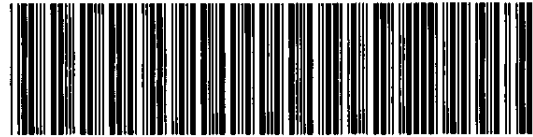

ARTICLES OF INCORPORATION

GENOVA INTERNATIONAL CORP

ARTICLE I - NAME

The name of this corporation is: GENOVA INTERNATIONAL CORP

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence at the time of filing these Articles of Incorporation.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all business permeated under the laws of the United States of America and the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue up to Five Thousand (1,000) shares of common stock with a par value of \$ 1.00 Dollar per Share.

ARTICLE V – PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any stock of this corporation of the same kind, class series as that which he already holds, shall have the right to purchase his prorate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

This corporation shall have all powers necessary or convenient to affect its purposes as enumerated in the Florida General Corporation Act.

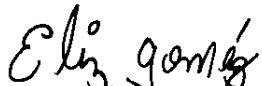
All corporate powers shall be executed by under the authority of, and the business and affairs of this corporation shall be managed under the direction of the board of directors.
