ARTICLES OF INCORPORATION OF New Venture Coach, Inc.

ARTICLE I NAME

The name of this Corporation shall be: New Venture Coach, Inc., and its principal street and mailing address is 14703 Park of Commerce Boulevard, Jupiter, Florida 33478

ARTICLE II NATURE OF BUSINESS

This Corporation is being formed for the following purposes.

- a) To act as a teaching vehicle and consultant for entrepreneurial and any and all other lawful business or activity permitted under the laws of the United States and the State of Florida.
- b) To generally have and exercise all powers, rights and privileges necessary and incident to carrying out properly the objects herein mentioned.
- c) To do anything and everything necessary, suitable, convenient or proper for the accomplishment of any of the purposes or the attainment of any or all of the objects hereinbefore enumerated or incidental to the purposes and powers of the Corporation or which at any time appear conductive thereto or expedient.

ARTICLE III TERM OF EXISTENCE

This Corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is the date on which these Articles of Incorporation are filed with the Secretary of State of the State of Florida.

ARTICLE IV CAPITAL STOCK

- a) Authorized Capital Stock. The Corporation is authorized to issue 1,000 shares of Common Stock, par value \$0.01 per share.
- b) No Preemptive Rights. No stockholder of this Corporation shall, because of his ownership of stock, have a preemptive or other right to purchase, subscribe for or take any part of any stock, whether common or preferred, of any part of any notes, debentures, bonds or other securities convertible into or carrying options to purchase the stock of this Corporation whether issued or unissued. Any securities of the Corporation may at any time be issued, optioned for sale, sold or disposed of by this Corporation pursuant to resolution of its Board of Directors to such person or persons and upon such

terms as the Board may deem proper without first offering such securities or any part thereof to existing stockholders.

ARTICLE V INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of the Corporation is 14703 Park of Commerce Boulevard, Jupiter, Florida 33478, and the name of the initial registered agent of this Corporation is Bruce W. Keihner.

ARTICLE VI INITIAL DIRECTORS

ARTICLE VII DIRECTOR QUORUM AND VOTING

No less than a majority of the directors shall constitute a quorum for a meeting of directors. If a quorum is present, the affirmative vote of a majority of the directors present, or, if director or directors have abstained from voting because of an interest in the matter to be voted on, the affirmative vote of a majority of the directors present and voting, shall be the act of the Board of Directors.

ARTICLE VIII VOTING REQUIREMENTS FOR SHAREHOLDERS

The affirmative vote of a majority of the shareholders of this Corporation entitled to vote shall be required for the authorization of any action of the shareholders of this Corporation.

ARTICLE IX AMENDMENTS TO ARTICLES OF INCORPORATION AND BY-LAWS

This Corporation reserves the right to amend or repeal any provisions contained in these. Articles of Incorporation or any amendments hereto. Any right conferred upon the shareholders is subject to this reservation. Further, the power to adopt, alter amend or repeal the By-Laws shall be vested in the Board of Directors of this Corporation.

ARTICLE X POWERS

This Corporation shall have all of the corporate powers enumerated in the Florida Business Corporation Act, as amended from time to time.

ARTICLE XI

Dividends payable in shares of any class may be paid to the holders of shares of any other class.

ARTICLE XII INDEMNIFICATION

This Corporation shall indemnify and hold harmless any and all of its directors, officers, employees or agents or former directors, officers, employees or agents or any person or persons who may have served at its request as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise in which it owns shares of capital stock or of which it is a creditor, to the fullest extent permitted by the law. - b) No contract or other transaction between the Corporation and any other corporation or entity, in the absence of fraud, shall be affected or invalidated by the fact that any one or more of the officers or directors of the Corporation is or are interested in or is an officer or director or are officers or directors of such other corporation or entity, and any officer, officers or directors, individually or jointly, may be a party or parties to or may be interested in any such contract or transaction of the Corporation or in which the Corporation is interested; and no contract, act, transactions of the Corporation with any person or persons, firm, entity, or corporation, in the absence or fraud, shall be affected or invalidated by the fact that any officer, officers, or directors of the Corporation is a party or are

parties to or interested in such contract, act or transaction, or in any way connected with such person or persons, firm, entity or corporation, and each and every person who may become an officer or director of this Corporation is hereby relieved from any liability that might otherwise exist from thus contracting with the Corporation for the benefit of himself or any firm, association, entity, or other corporation in which he may be in any way interested.
