ARTICLE I, NAME OF CORPORATION:

The name of the Corporation shall be:

CACERES AND MINAYA, CORP.

ARTICLE II, GENERAL NATURE OF THE BUSINESS:

The general nature of the business and the object and purposes to be transacted and carried on are.

To conduct any and all business not prohibited by the Laws of the United States and State of Florida.

To conduct business in, have one or more offices, ACCOUNTING SERVICES, TAX PREPARATION.

To purchase the corporate assets or any other Corporation and engage in the same or other character of business.
