In compliance with Chapter 607, Florida Statutes, the undersigned acting as Incorporators do hereby adopt and file the following Articles of Incorporation for the purpose of organizing a corporation.

ARTICLE I

NAME

The name of the Corporation is **MONARCH ASSOCIATES, INC.**

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The street address, and the mailing address, of the initial principal office of the Corporation is 2167 Deer Run Trail, Jacksonville, Florida 32246.

ARTICLE III

DURATION

The existence of the Corporation shall begin on the date of filing with the Department of State, Division of Corporations, State of Florida, and the term of duration of the Corporation shall be perpetual.

INDEMNIFICATION


The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law and as otherwise provided for in the Bylaws.
