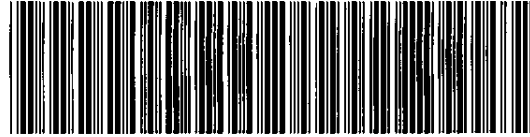



Michael Guirado is hereby deleted as Registered Agent of the Corporation.


Dayanys Lagoa shall be the Registered Agent of the Corporation at 10378 W. Flagler Street, Miami, Florida 33174.
