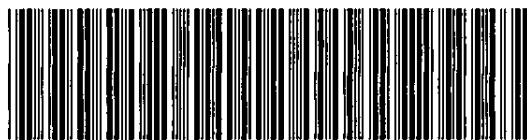

**REGISTERED AGENT/REGISTERED OFFICE/PRINCIPAL OFFICE:**


Dayanys Lagoa shall be the Registered Agent of the Corporation 9240 SW 72 Street, Suite 106, Miami, Florida 33173.
