ARTICLES OF INCORPORATION

The undersigned for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

Corporate Name. The name of this corporation is **K12 TSHIRTS, INC.**

ARTICLE II

Duration. The duration of this corporation is perpetual.




