CERTIFICATE OF INCORPORATION

OF

JUNE PLUM ENTERPRISES INC.

We, the undersigned, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of an Act of the legislature of the State of Florida approved

June 1, 1925, and the acts amendatory thereto, do hereby subscribe to this Certificate of incorporation.

FIRST: The name of the corporation is JUNE PLUM ENTERPRISES INC.

SECOND: The general nature of the business to be transacted by the corporation is as follows: To act as general traders and internet traders of goods and merchandise. To import and export goods and merchandise. To manufacture, purchase, or otherwise acquire, and to own and mortgage, pledge, sell, assign, and transfer or otherwise dispose of, and to invent, trade, deal in and with goods, wares, merchandise, and other personal and are property of every class and description whatsoever.

To buy, sell, manufacture, repair alter and exchange, let or WIRG. export and deal in all kinds of articles and things which MMY be required for the purposes of any of the said business or commonly supplied or dealt in by persons engaged in any such business, or which may be capable of being profitably dealt with in connection with any of the said business.

To guarantee, acquire by purchase, subscription, or otherwise
