

#### ARTICLES OF INCORPORATION

The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

#### **ARTICLE I -NAME**

The name of the corporation shall be Recruiting Advisors, Inc..

#### **ARTICLE II - COMMENCEMENT & DURATION**

The corporation shall commence its existence on March 1, 2008 and shall exist perpetually unless sooner dissolved according to law.

#### **ARTICLE III - ADDRESS**

#### ARTICLE V - REGISTERED AGENT

#### ARTICLE VI - INCORPORATOR

#### ARTICLE VII - BOARD OF DIRECTORS

The corporation shall have two directors initially. The number of directors may be increased or decreased from time to time thereafter according to the bylaws of the corporation but shall never be less than one. #### ARTICLE VIII - SHAREHOLDER PROPERTY

Private property of the shareholders shall not be subject to the payment of the corporation's debts. The corporation shall have a first lien on the shares of its shareholders and upon the dividends due them for any indebtedness of the shareholders to the corporation.

## **ARTICLE IX - AMENDMENTS TO ARTICLES**

The Directors shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.
