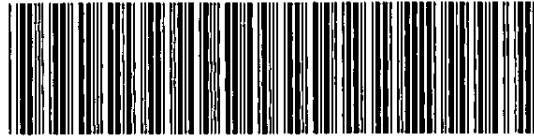

The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida General Corporation Act.

ARTICLE I - NAME

The name of this corporation is **CAA FOOD SERVICES, INC.**

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in the business of fast food services, and any other activity permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

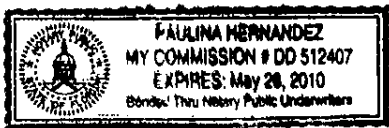
