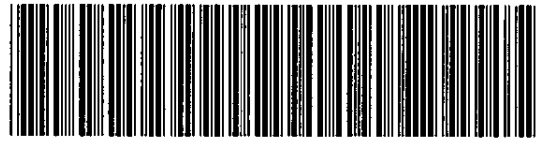



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be Favoretta Lawn, Inc., hereinafter referred to as the "Corporation."

ARTICLE II

The principal office and initial street address of the Corporation in the State of Florida is 74 County Road 202, Bunnell, Florida 32110 and the mailing address of the is P.O. Box 2993, Bunnell, Florida 32110

ARTICLE III

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

The Corporation has the authority to issue One Thousand (1,000) shares of common stock with a par value as may be established by the Board of Directors of the Corporation.
