TO
ARTICLES OF INCORPORATION

1. That the name of the corporation is CGC.COM, INC. (the "Corporation").
2. 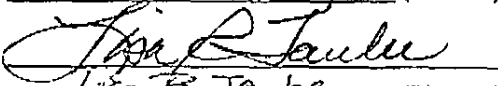

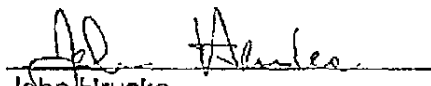
