ARTICLES OF INCORPORATION
OF
FUSSELL COMPANY
a Florida Corporation

The undersigned, acting as Incorporator of FUSSELL COMPANY, a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME and ADDRESS

The name of the Corporation is FUSSELL COMPANY. The street address of the initial principal office of the Corporation is 1201 W. Cypress Creek Road, Suite 200, Fort Lauderdale, FL 33309.

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.


