Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

FIRST: The name of the corporation is Arrigo DCJ Sawgrass, Inc.

SECOND: The corporation filed its Articles of Incorporation on March 5, 2008, and was assigned Florida Document Number P08000024086. The corporation filed Articles of Amendment to Articles of Incorporation on March 13, 2008, which changed the name of the corporation to Arrigo DCJ Sawgrass, Inc.

THIRD: The Articles of Incorporation, as previously amended, are further amended as follows:

A. ARTICLE IV is deleted in its entirety and replaced with the following:

## ARTICLE IV

The corporation is authorized to issue 1,000 voting shares, and 999,000 non-voting shares, of common stock, with each share having a par value of \$1.00. Except for the right to vote, each voting share and each non-voting share shall have identical rights, including the rights to share in and receive distributions and liquidation proceeds.
