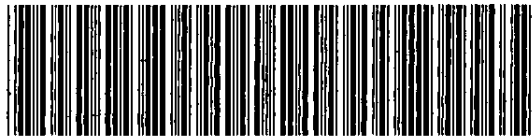

**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION**

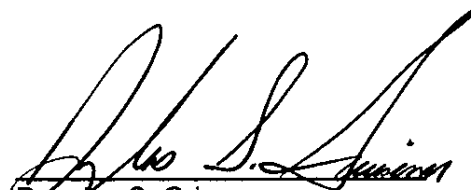
1. The name of the corporation is Advantage Home Builders, Inc.

ARTICLE IV

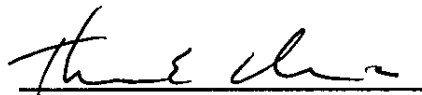
