ARTICLE 1

ARTICLE 2

DURATION

THIS CORPORATION SHALL EXIST PERPETULLY, AN THE DATE OF COMMENCEMENT OF CORPORATION EXISTANCE SHALL BE THE DATE ON WHICH THESE ARTICLES ARE FILED WITH THE SECRETARY OF STATE IN THE STATE OF FLORIDA.

ARTICLE 3

PROPERTY OR LABOR MAY ALSO BE PURCHASED WITH THE CORPORATE ATSU SUCH VALUATION AS MAY BE FIXED BY THE DIRECTORS.
- B. THE SAID STOCK SHALL BE ISSUED PURBANT TOA PLAN UNDER SECTION 1244 OF THE INTERNAL REVENUE SERVICE CODE.
- C.
