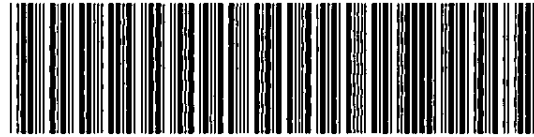

**ARTICLES OF INCORPORATION
OF
JAKALA, INC.**

ARTICLE ONE

The name of this Corporation is JAKALA, INC. and the mailing address of the Corporation shall be 2319 Bainmar Drive, Lehigh Acres, Florida 33971.

The date of the commencement of corporate existence of the Corporation shall be the date these Articles are filed with the Secretary of State.

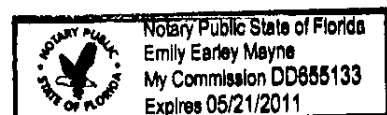
