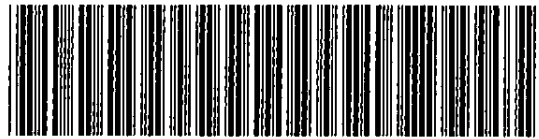

By laws will be formulated and implemented by the initial Board of Directors once appointed.

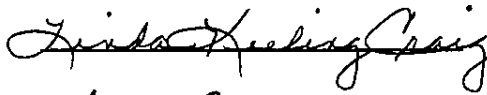
