# ARTICLES OF INCORPORATION OF

#### ARTICLE I NAME OF CORPORATION

The name of this corporation is THE VERANDAS GP, INC. (hereinafter called the S' "Corporation").

#### ARTICLE II PRINCIPAL OFFICE

The street address of the principal place of business and mailing address, if different, of the Corporation are:

414 East Charlotte Avenue Punta Gorda, Florida 33950

#### ARTICLE III CORPORATE PURPOSE

The general nature of the business and objects to be transacted, promoted or carried on are to do any and all of the things hereinafter mentioned as fully and to the same extent as natural persons might or could do, to-wit:

- (a) to provide and develop affordable housing opportunities to low and moderate income persons and/or families primarily located in, but not limited to, Punta Gorda, Florida, and the surrounding areas; and
- (b) in general, to have and exercise any other powers conferred by the laws of the State of Florida upon corporations generally, it being hereby expressly provided that the enumeration of specified powers shall not be held to limit or restrict in any manner the general powers of the Corporation.

#### ARTICLE IV AUTHORIZED STOCK

The aggregate number of shares which this Corporation shall be authorized to issue is SEVEN THOUSAND FIVE HUNDRED (7,500) shares of common stock with a par value of One Dollar (\$1.00) per share, and the initial Stockholder of this Corporation is PUNTA GORDA HOUSING AUTHORITY, a public body corporate and politic organized and existing under the laws of the State of Florida, which shall be issued FIVE HUNDRED (500) shares of said common stock. This Corporation shall not have the authority to issue shares in series.

## ARTICLE V INITIAL BOARD OF DIRECTORS

The affairs of the Corporation shall be managed by the Board of Directors. The manner in which the directors are elected or appointed: when appointed to serve on the Board of Commissioners of Punta Gorda Housing Authority, such member shall automatically be deemed to serve as a director of the Corporation.

Each director shall have one vote in the election of officers and in the conduct of all the business of the Corporation. There shall be no individual liabilities against any director for corporate debts.
