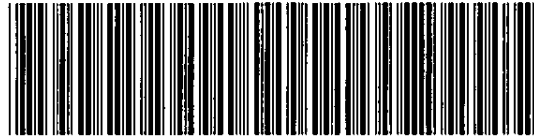

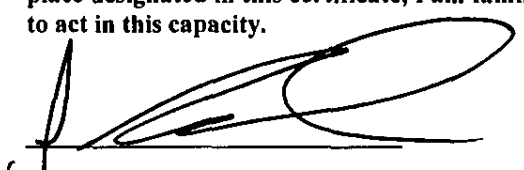
ARTICLE X AMENDMENT

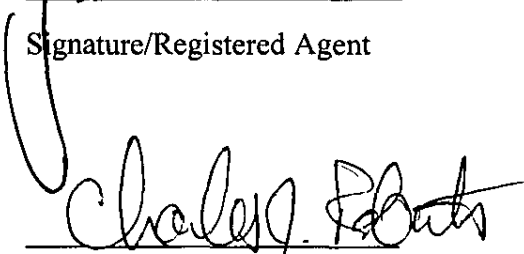
