The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

Section 1.1 <u>Name</u>. The name of the corporation is Urban Edge Member Corporation.

Section 1.2 <u>Address of Principal Office</u>. The address of the principal office of the corporation is 724-A 2nd Avenue South, St. Petersburg, Florida 33701.

ARTICLE II

DURATION

Section 2.1 <u>Duration</u>. This corporation shall exist perpetually.
