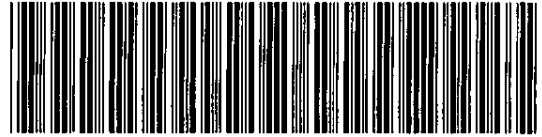

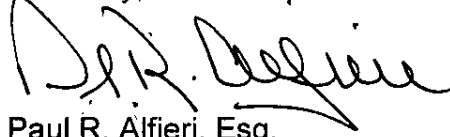

ARTICLE I - NAME

The name of this corporation is **MAVAN, INC.**
