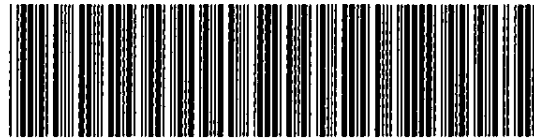

NAME

- 1.1 The name of the corporation is ARCHER & ASSOCIATES LAW FIRM, P.A.

ARTICLE II

DURATION

- 2.1 The corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida

ARTICLE III

PURPOSE

- 3.1 This corporation is organized for the following purposes:
- a. To engage in the practice of law as a professional law corporation and to carry on services incident to the practice of law. The practice of law shall be the sole and exclusive professional service to be rendered by this corporation

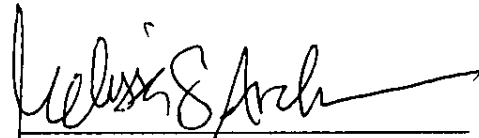

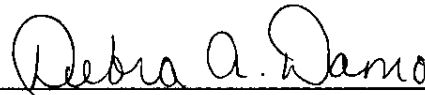
