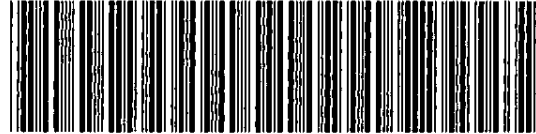

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME AND ADDRESS**

The name of the corporation shall be KEW Group, Inc. (the "Corporation"). The address of the principal office of the Corporation shall be 1324 Forestedge Blvd., Oldsmar, Florida 34677, and the mailing address shall be the same.

**ARTICLE II. NATURE OF BUSINESS**

The Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

**ARTICLE III. CAPITAL STOCK**
