ARTICLES OF INCORPORATION OF MC REO HOLDING CO.

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

ARTICLE 1 NAME

The name of the corporation is MC REO Holding Co. (the "Corporation").

ARTICLE 2 PRINCIPAL OFFICE

The street address and mailing address of the principal office of the Corporation is 9350 Conroy-Windermere Road, Windermere, Florida 34786.

ARTICLE 3 AUTHORIZED SHARES

The Corporation shall have authority, to be exercised by the Board of Directors, to issue no more than one thousand (1,000) shares of capital stock, consisting of one thousand (1,000) shares of common stock ("Common Stock"), no par value.

- Section 3.1 <u>Common Stock</u>. Common Stock of the Corporation shall possess all such rights and privileges as are afforded to capital stock by applicable law in the absence of any express grant of rights or privileges in the Corporation's Articles of Incorporation, including but not limited to, the following rights and privileges:
- a. <u>Dividends</u>. Dividends may be declared and paid or set apart for payment upon Common Stock out of any assets or funds of the Corporation legally available for the payment of dividends;
- b. <u>Voting Rights</u>. The holders of Common Stock shall have the right to vote for the election of directors and on all other matters requiring shareholder action, each share being entitled to one vote; and
- c. <u>Distributions</u>. Upon the voluntary or involuntary liquidation, dissolution or winding-up of the Corporation, the net assets of the Corporation available for distribution shall be distributed pro rata to the holders of Common Stock in accordance with their respective rights and interests.

ARTICLE 4 INITIAL REGISTERED OFFICE AND AGENT

The name of the initial registered agent of the Corporation is Tyler Piercy, and the street address of the initial registered office of the Corporation in the State of Florida is 9350 Conroy-Windermere Road, Windermere, Florida 34786.

The written acceptance of the initial registered agent, as required by the Florida Business Corporation Act, is set forth following the signature of the incorporator and is made a part of these Articles of Incorporation.

ARTICLE V BOARD OF DIRECTORS

Section 5.1 <u>Initial Board of Directors</u>. The initial board of directors (hereinafter "Board of Directors") shall consist of two (2) members. The name and address of each member are:

If the Florida Business Corporation Act is hereby amended to further eliminate or limit the personal liability of directors, then the liability of a director of the Corporation shall be eliminated or limited to the fullest extent permitted by the Florida Business Corporation Act, as so amended.
